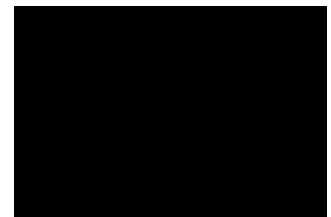
City of Omaha Parks and Recreation is hosting the only event of this kind in the Omaha area. The meet is designed to introduce children between the ages of 9-14 to physical fitness through track & field. The Hershey Youth Track and Field Games are sponsored by The Hershey Company, the National Recreation and Park Association, USA Track & Field and Athletics Canada.

All participants must be at the Westside Middle School track, 8601 Arbor Street by 11:00 a.m. Participants can enter either two track and one field event or two field and one track event. No shoes designed for spikes are allowed in the running events and shoes designed for turf surface sports are not allowed in the field events. There will be no starting blocks.

The first and second place finishers will be eligible for the State Finals to be held in Grand Island on June 7, 2014. The winners of the State Meet will be eligible for a Regional Team that travels, at no cost to the participant, to Hershey, Pennsylvania for the National Finals on August 2, 2014. The regional team will be selected from Nebraska, Kansas, North Dakota, South Dakota, Colorado, Wyoming, and the Prairie Provinces of Canada. Each state is guaranteed a minimum of 5 participants.

Not every winner at the State/Provincial Final will automatically advance to the North American Final due to the geographical distribution rule which states that a minimum of five participants from each State/Provincial Group will compete in the North American Final. A participant may enter only one Local and /or District Meet. All regional winners will qualify for the North American final Meet.
